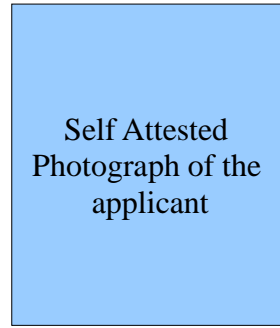

CRITERIA

“The applicants having minimum 3 years practice as an advocate with average annual income of not less than Rs.24,000/- would be eligible, subject to condition that a candidate for re-appointment as an Oath Commissioner should be eligible after three years of the expiry of his term.

The above income criteria will not be applicable to handicapped/disabled and lady Advocates who are divorcee/widow/single.”
