Subject:- **Subsequent allotments of Lawyers' Chambers under Rules 8 (i) of Allotment Rules in Lawyers' Chamber Block, District Court Complex, Saket, New Delhi.**

Whereas, applications were invited *inter-alia*, from physically challenged advocates vide notice published on 19.08.2013 for subsequent allotment of lawyers' chambers under Rules 8(i) of Allotment Rules in Lawyers Chambers Block in District Court Complex, Saket, New Delhi in accordance with the Saket District Court Lawyers' Chambers (Allotment and Occupancy) Rules, 2010 (hereinafter referred to as the "Allotment Rules") on double occupancy basis;

And whereas, inter alia, on the basis of further scrutiny of the aforesaid applications of 04 (four) applicants who have submitted further responses and submissions, the Allotment Committee has prepared and finalized the results as indicated in **List FF-1/C**. Out of 04 (four) two applicants were given time to submit further documents and applications of two applicants were rejected.

And whereas the two applicants have submitted further documents and their requests have been allowed as per list FF1/D are hereby offered allotment of chamber on double occupancy basis, against the concerned reserved category, subject to the following conditions to be fulfilled **on or before 01.08.2014**:-

- (i). The advocates shall furnish along with letter of acceptance on affidavit, *inter alia*, affirming the following information/declaration (duly supported by attested copies of requisite documents):-
 - (a). The enrolment with Bar Council of Delhi;
 - (b). Membership of Saket Bar Association;
 - (c). That neither they nor their spouse have ever acquired, built, been allotted or have been in possession of any space or chamber in any Courts Complex in Delhi; and
 - (d.) In case of category of physically challenged advocates, duly attested copy of disability certificate issued by Medical Board of Govt. Hospital.
- (ii). The above mentioned date i.e. **01.08.2014** shall not be extended under any circumstances nor any representation for such purposes shall be entertained.
- (iii). Upon compliance being made as above, the Allotment Committee shall take up the claims of the advocates included in **List FF-1/D** in order of seniority as per terms stipulated in the Notice inviting applications for specific allotment, subject to confirmation on basis of documents

submitted and further formalities being complied with.

- (iv). In case the compliance of the above conditions is not made **on or before 01.08.2014**, the provisional offer of allotment of chamber of double occupancy basis shall stand withdrawn/ forfeited forthwith and without any further notice.
