
ORDER No. 79 Dated 12.9.2014

Pursuant to Delhi High Court order no. 21/DHC/Gaz./G-1/VI.E.2(a)/2014 dated 10.09.2014, all the cases pertaining to the Jurisdiction of Police Station Govind Puri, Kalka Ji, Sarita Vihar and Pul Prahlad Pur, pending in the court previously presided over by Sh. Prem Kumar Barthwal PO MACT-01, South East, are hereby withdrawn and assigned to the court of Sh. 
Note : Ahlmad of the abolished court is directed to send the files immediately to the transferee court and to display the list of cases outside the court room, specifying the name of transferee court.
