On Sunday and other Holidays they are required to reach court around 11:00 AM. and shall not leave before 5:00 PM or till the disposal of the entire remand and other misc. work, whichever is later. Even on working days, Duty Magistrate are expected to remain in the court till 5:00 PM. The Duty Magistrate would be assisted by his/her own staff.
