

In case where a particular officer is expected to work as Link Magistrate, in more than one court on given day, the reader of court concerned shall inform the litigants and members of the Bar about the time when the 2nd Link Magistrate would be coming to such court. (refer circular No. 5958-6040/CMM dated 19.07.1999).

(D) In connection with order No. 38 Dated :- 27.08.2013 passed by the Ld. Officiating District & Sessions Judge, South East District, Saket Courts, New Delhi. It is impressed upon that Ms. Anu Aggarwal, Ld. MM-09, South East, New Delhi shall deal with the cases under section 138 NI Act which were assigned vide the abovesaid order to Sh. Dinesh Kumar, Ld CJ, South East, Saket Courts, New Delhi in his absence or non-availability or being on leave and in absence of Ms. Anu Aggarwal, Ld.
